1- Introduction:

Cooss Marche is Partner of the project Adriatic Model of Sustainable Mobility in the Health & Care Sector, reference number 1°str./0009/0, approved in the Call for Strategic Projects of the Adriatic IPA CBC Programme.

AdriHealthMob deals with the Strategic Priority of sustainable transport services, focusing the specific sector of Health and Care, where mobility is increasing and showing an enormous potential within the cross-border environment. The project is aimed at developing sustainable transport services, models and schemes addressing a cross-border health and care system in the whole Adriatic area.

Cooss Marche is the coordinator of the Communication & Dissemination Work Package. The final dissemination process was organized within a road show, named AdrionTechniCare (www.adriontechnicare.eu). Previously were selected 2 service providers to provide to the project Consortium Communication & Dissemination Assistance and the Integrated Management of Meeting and Events and promotion.

During the last project change, as approve by RA/22466 of MA, 2 main outputs were upgraded in the project additionally to already foreseen constitution of the AHCMA association:

- -the incorporation of a SpinOff (Aicare.srl under incorporation) that will make accessible to the Adrion care Market the aicare.eu services.

In the final weeks of the project finalization, a promotion service will be hired in order to strengthen and disseminate through an important campaign the above listed three main project outputs.

Cooss Marche is launching the present Expression of Interest, in order to identify additional operators to those already present in Cooss Marche internal database, in order to shortlist at least three Service Providers to be invited to a Competitive Negotiated Procedure.

The company must demonstrate, attaching an updated CV to have the necessary capacities to provide the service.

The shortlisted companies will be invited to submit the technical and Financial proposal within, September, 10th, 2016. The development activity will start in September 2016, and will last within AdriHealthMob project closure.

- i) has not granted and will not grant, has not sought and will not seek, has not attempted and will not attempt to obtain, and has not accepted and will not accept any advantage, financial or in kind, to or from any party whatsoever, where such advantage constitutes an illegal practice or involves corruption, either directly or indirectly, inasmuch as it is an incentive or reward relating to award of the contract;
- j) provided accurate, sincere and complete information to the contracting authority within the context of this procurement procedure;
 - acknowledges that [the above-mentioned legal person][he][she] may be subject to administrative and financial penalties² if any of the declarations or information provided prove to be false.

In case of award of contract, the following evidence shall be provided upon request and within the time limit set by the contracting authority:

For situations described in (a), (b) and (e), production of a recent extract from the judicial record can be in the future required or, failing that, a recent equivalent document issued by a judicial or administrative authority in the country of origin or provenance showing that those requirements are satisfied. Where the tenderer is a legal person and the national legislation of the country in which the tenderer is established does not allow the provision of such documents for legal persons, the documents should be provided for natural persons, such as the company directors or any person with powers of representation, decision making or control in relation to the tenderer.

For the situation described in point (d) above, Cooss Marche can require in the future recent certificates or letters issued by the competent authorities of the State concerned are required. These documents must provide evidence covering all taxes and social security contributions for which the tenderer is liable, including for example, VAT, income tax (natural persons only), company tax (legal persons only) and social security contributions.

For any of the situations (a), (b), (d) or (e), where any document described in two paragraphs above is not issued in the country concerned, it may be replaced by a sworn or, failing that, a solemn statement made by the interested party before a judicial or administrative authority, a notary or a qualified professional body in his country of origin or provenance.

If the expert is represented by a legal person, information on the natural persons with power of representation, decision making or control over the legal person shall be provided only upon request by the contracting authority.
